

# Privacy Policy

This privacy policy governs your use of the software application Catholic Liturgical Calendar, ("Application") for mobile devices that was created by Kiss Devs Software Company.

The Application enables you to access daily readings of the Roman Catholic Church from your phone.

Among other features it offers you are:

- Daily readings of Catholic mass
- Daily Psalms
- Full Liturgical Calendar 2018
- Common Prayers
- Church Holy Days
- Liturgical Seasons
- Mass Order
- The Rosary

## **What information does the Application obtain and how is it used?**

### **User Provided Information**

The Application obtains the information you provide when you download the Application. No registration is required to use the application. However, please keep in mind that at a future date, registration may be required so as to enable newer and advanced functions.

During premium version activation, a license is required in which case some personal information is required. This is your name, email address and phone number and the device identifier. This information is required for generating a licence key for the specific device and tying it up to the email address provided.

Information provided when adding items such as Notes is kept on your mobile application and is never shared with neither us, Kiss Devs Software Company, or any other party.

We may also collect some information such as your email address when providing feedback on the application to enable us to get back to you thereafter.

We may also use the information you provided us to contact you from time to time to provide you with important information, required notices and marketing promotions.

### **Automatically Collected Information**

In addition, the Application may collect certain information automatically, including, but not limited to, the make and model of mobile device you use, the IP address of your mobile device, your mobile operating system, advertising id and general anonymized information about the way you use the Application.

### **Does the Application collect precise real time location information of the device?**

This Application does not collect precise information about the location of your mobile device.

### **Do third parties see and/or have access to information obtained by the Application?**

No third party has access to any of the information collected.

### **What are my opt-out rights?**

You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network. ### **Data Retention Policy, Managing Your Information**

We will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. We will retain Automatically Collected information for up to 24 months and thereafter may store it

in aggregate. Please note that some or all of the User Provided Data may be required in order for the Application to function properly.

## **Children**

We do not use the Application to knowingly solicit data from or market to children under the age of 13. We will delete such information from our files within a reasonable time.
